# When you contact us

The information you provide (personal information such as name, address, email address, phone number, organisation) will be processed and stored so that it is possible to contact you and respond to your correspondence, provide information and/or access our facilities and services. Your personal information will be not shared or provided to any other third party unless you give us specific permission to do so.

#### North West Ipswich Big Local Trust's Right to Process Information

## **Information Security**

North West Ipswich Big Local Trust will ensure the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and appropriate policies.

We will only keep your data for the purpose it was collected for and only for as long as is necessary. After which it will be deleted.

#### Children

We will not process any data relating to a child (under 13) without the express parental/guardian consent of the child concerned.

## Right to Object
